MINUTES

The City Council of the City of Laurinburg held its regular monthly meeting December 20 2011 at 7:00 p.m. in the council room of the Municipal Building with the Honorable Thomas W. Parker III, Mayor, presiding. The following Councilmembers were present: Curtis B. Leak, Herbert M. Rainer Jr., Kenton T. Spencer, Mary Jo Adams, and Andrew G. Williamson, Jr.

Also present were: Edward F. Burchins, City Manager, Dolores A. Hammond, City Clerk, and William P. Floyd, Jr., Assistant City Attorney.

Mayor Parker called the meeting to order at 7:00 p.m.

APPROVAL OF AGENDA

Mayor Parker recognized Senator William R. Purcell, II to comment as former Mayor and councilmember. Senator Purcell stated that his relationship with the Peele family went back many years. He added that it was a great honor to recognize Mr. Peele for his many years of service to the City and to the community. CONSENT AGENDA

The City Manager reviewed the consent agenda.

- a. Approve minutes from the October 18, 2011 regular meeting; November 15, 2011 agenda workshop; November 22, 2011 organizational meeting; and November 22, 2011 regular meeting
- b. Consider setting date for public hearing January 17, 2012 at 7:00 p.m. in the upstairs council room of the Municipal Building located at 303 West Church Street to hear a request to rezone a 23-acre tract of land on Woodlawn Street from Residential-6 and Residential-15 to Office/Institutional
- c. Annual Firefighters Certification
- d. Consider Ordinance No. O-2011-22 condemning the property located at 606 E. Covington Street directing the Building Inspector to demolish the dwelling (estimated

- demolition costs \$8,500.00)
- e. Consider Ordinance No. O-2011-23 condemning the property located at 255 Dickson Street and directing the Building Inspector to demolish the dwelling (estimated demolition costs \$4,500.00)
- f. Consider Resolution No. R-2011-21 approving the City of Laurinburg Facebook Policy.

Mrs. Brandi Deese stated that the estimated cost for demolition of 606 E. Covington St. was \$8,500.00 and that the estimated condemnation cost of 255 Dickson Street was \$4,500.00. She cautioned that asbestos testing had not been performed and if asbestos is found in either building, the demolition costs will increase.

Upon question by Councilmember Spencer, Mr. Burchins stated that \$40,000.00 was budgeted for demolitions and less than half of that amount had been used.

Councilmember Leak expressed concern about demolition occurring near the courthouse. Mrs. Deese stated she would check on that to ensure safety.

Councilmember Leak moved for the approval of the Consent Agenda as presented with demolition costs included in items d. and e. Councilmember Williams seconded the motion, and it was approved by the following vote:

PUBLIC HEARING TO CLOSEOUT THE 2009 COMMUNITY DEVELOPMENT BLOCK GRANT INFRASTRUCTURE PROJECT 09-C-2015

The City Manager explained this public hearing is to closeout the 2009 Community Development Block Grant Infrastructure Project on West Boulevard.

Mrs. Brandi Deese stated that in accordance with the regulations of the North Carolina Department of Commerce, a public hearing must be held before final closeout of the Scottish Glen Phase II/West Boulevard Grant. She added that the grant was in the amount of \$250,000.00 which represented 96% of the total project costs.

Mayor Parker declared the public hearing open.

There was no one to speak for or against the closeout of the 2009 Community Development Block Grant Infrastructure Project 09-C-2015.

Mayor Parker closed the public hearing.

PUBLIC HEARING TO CONSIDER APPLICATION FOR COMMUNITY DEVELOPMENT BLOCK GRANT FROM THE DEPARTMENT OF COMMERCE

The City Manager explained that this public hearing was to consider application for Community

Development Block Grant (CDBG). He added that the City holds a blanket public hearing in the event the City decides to apply for any CDBG funds during the year 2012. He further added that this first public hearing is required, and if the City decides on a future project another public hearing would be required.

Mayor Parker declared the public hearing open.

There was no one to speak for or against this matter.

Mayor Parker closed the public hearing.

**PUBLIC HEARING TO REZONE FROM RESIDENTIAL-15 TO GENERAL BUSINESS
CONDITIONAL USE DISTRICT PROPERTY LOCATED AT 907 S. MAIN ST. TO
OPERATE A BAKERY**

Mrs. Brandi Deese explained that Mr. Lester Forde requested that the property at 907 S. Main Street be rezoned from Residential-15 to General Business Conditional Use District for the purpose of operating a bakery. She added that Mr. Forde never considered this property for commercial use; however, with his family history in the bakery business, he was open to the use of the property as a bakery provided the use of the property is limited to a bakery only. She explained that with the Conditional Use District zoning, if the bakery is not successful, the property would revert back to residential use. She further added that this request will be in harmony with the surrounding area and the conditional use district zoning provides for the intended use without opening it up to the entire range of uses permitted in the General Business zoning district.

Upon question by Councilmember Leak, Mrs. Deese stated that there had not been any opposition to the request.

Upon questions by Councilmember Spencer, Mrs. Deese explained that when a conditional use permit is requested, Council considers whether the intended use could be compatible for the property as currently zoned and may determine any conditions that need to be placed upon the use. She further explained that the Conditional Use District rezoning is used if the developer has a set developmental plan. She added that when a developer meets with Planning staff to consider rezoning property or requesting a conditional use permit, staff advises the developer as to what would be best, but ultimately the decision remains with the developer whether they apply for rezoning or a conditional use permit. If the property is sold, the zoning goes with the land.

Mayor Parker declared the hearing open.

Ms. Christy Leviner, representing McMillan Rentals, appeared before Council and stated that McMillan Rentals would be renting the subject property for the owner. She added that there would be few changes to the property other than a sign in the front yard and the possibility of a few trees removed from the side yard.

Upon question by Councilmember Leak, Mrs. Deese explained that once the site plan had been submitted, staff would determine the number of parking spaces required.

There was no present to speak in opposition to this request.

Councilmember Rainer explained that he is related to the petitioner and questioned whether he needed to abstain from voting on this request.

The City Clerk explained that unless he had a direct financial interest, he was required to vote.

Councilmember Rainer moved to approve Ordinance No. O-2011-21 which rezones the property located at 907 South Main St. from Residential-15 to General Business Conditional Use District to operate a bakery as such rezoning is:

- Consistent with other development in the area;
- Advances the public health, safety or welfare; and
- Provides a positive impact to the public at large.

Councilmember Spencer seconded the motion, and the vote was as follows:

RESOLUTION NO. R-2011-19 AUTHORIZING MAYOR AND CITY CLERK TO EXECUTE EASEMENT TO PIEDMONT NATURAL GAS COMPANY, INC. FOR THE AMOUNT OF \$3,000.00, AND APPROVAL OF RESOLUTION NO. R-2011-20 AUTHORIZING MAYOR AND CITY CLERK TO EXECUTE EASEMENT TO PIEDMONT NATURAL GAS COMPANY, INC. FOR THE AMOUNT OF \$75,000.00

Mayor Parker stated that because he and Councilmember Spencer are both on the Board of the Laurinburg-Maxton Airport Commission. He requested that Mayor Pro Tem Spencer preside over the meeting so that he could present information to Council concerning this matter since there were conflicts for the Airport Commission Director and the Commission attorney.

Mr. Thomas Parker of the Laurinburg-Maxton Airport Commission appeared before Council to request Council's approval of Resolution No. R-2011-19 which authorizes the Mayor and City Clerk to execute an easement to Piedmont Natural Gas Company, Inc. for the amount of \$3,000.00 and approval of Resolution No. R-2011-20 which authorizes the Mayor and City Clerk to execute an easement to Piedmont Natural Gas Company, Inc. for the amount of \$75,000.00. He added that the bulk of this money will be repaid to the City of Laurinburg to the indebtedness resulting from the loan from the City to the Airport Commission for the resurfacing project.

Upon question by Councilmember Leak, the City Manager explained that the first payment from the Airport Commission was due June 30, 2012; therefore the Commission would be making an early payment and would also make a payment on June 30, 2012. He further explained that the repayment agreement is for 10 years at 4% interest. He added that the annual payment is \$50,000.00.

Upon question by Councilmember Leak, Mayor Pro Tem Spencer stated that the Town of Maxton Board was considering this matter.

Councilmember Leak moved to adopt Resolution No. R-2011-19 authorizing the Mayor and City Clerk to execute an easement to Piedmont Natural Gas Company, Inc. in the amount of \$3,000.00 and adopt Resolution R-2011-20 authorizing the Mayor and City Clerk to execute easement to Piedmont Natural Gas Company, Inc. in the amount of \$75,000.00. Councilmember Rainer seconded the motion, and it was approved by the following vote:

The City Manager stated that no workshop would be held in January since it conflicted with the Chamber Banquet.

Councilmember Spencer explained that he thought it would be beneficial for Council to hold a January workshop to discuss items that would be discussed at the joint meeting with the Scotland County Board of Commissioners on January 12, 2012.

A discussion ensued concerning items to be discussed at the joint meeting which included consolidation of taxes, consolidation of Information Technology (IT) Departments, the US 74 Lighting Project, Westpoint Stevens Water and Wastewater Plants, law enforcement agencies trading coverage areas for convenience, consolidation of Code Enforcement, Geographic Information System (GIS) and Planning and Zoning.

Following further discussion, motion was made by Councilmember Spencer to approve the Agenda Workshop Schedule amended to add a workshop on January 9, 2012 at 7:00 p.m. The motion was seconded by Councilmember Rainer, and the vote was as follows:

APPOINTMENTS

LAURINBURG BOARD OF ADJUSTMENT (MAYORAL APPOINTMENT)

Mayor Parker explained that the terms of the following members of the Laurinburg Board of Adjustment expire December 31, 2011:

Members: David Ellison and Iris Hamilton

Alternate Member: Joyce Jewell

He added that all three (3) individuals have expressed a desire to continue serving. Mayor Parker then reappointed David Ellison and Iris Hamilton to serve three-years terms as members of the Laurinburg Board of Adjustment with terms expiring December 31, 2014, and he reappointed Joyce Jewell to a three-year term as an alternate member of the Laurinburg Board of Adjustment with a term expiring December 31, 2014.

FIREMAN'S RELIEF FUND

Mayor Parker explained that the City Manager was appointed by the Council to serve on the Board of Trustees of the Fireman's Relief Fund with a term expiring January 2012; therefore an appointment for the term January 2012 to January 2014 needs to be made.

Motion was made by Councilmember Spencer, seconded by Councilmember Williamson, and unanimously carried to appoint the City Manager to the Fireman's Relief Fund Board of Trustees for a term to expire January 2014.

LUMBER RIVER COUNCIL OF GOVERNMENTS

Mayor Parker explained that Councilmember Spencer has resigned as alternate member to the Lumber River Council of Governments, and therefore, Council will need to make an appointment for an alternate member.

Motion was made by Councilmember Williamson, seconded by Councilmember Adams, and unanimously carried to appoint Mary Jo Adams to the Lumber River Council of Governments as an alternate member.

COMMENTS FROM MAYOR AND COUNCILMEMBERS

Mayor Parker announced that Councilmember Spencer's son won a Christmas card contest in the Scotland County School System.

Mayor Parker explained that he received a letter from Mrs. Ann Stack who was a history teacher in the Scotland County School System concerning the issue of voting districts discussed by several citizens at the November council meeting. He then read the letter, a copy of which is attached to and incorporated in these minutes.

Senator Purcell stated that the voting districts came about by a lawsuit filed by Mary Helen Speller based on the annexation in 1994. He explained that the City could have taken fought the lawsuit in court but instead decided to accept the voting districts.

ADJOURNMENT

Motion was made by Councilmember Spencer, seconded by Councilmember Adams, and unanimously carried to adjourn the meeting.
